Creator of the collection: Pickett Coal Company

Abstract: Records of the Pickett Coal Company. Collection contains the business

ledgers from the founding of the company by Richard Pickett and Abraham Edwards in the first part of the 19th century until the company was sold in 1910. The ledgers cover all goods and operations run by the company which in addition to coal includes fishing operations, sail

manufacturing, sales of small house hold goods, and wood.

Provenance: This collection was donated to the Beverly Historical Society

Access: Collection is open to researchers. Appointment recommended as materials

are not located at the Cabot house research facility.

Conservation: Smaller ledges were placed in archival box to protect them. All the

ledgers are in fair condition. The bindings on many are breaking. Front and back covers have separated. Leather volumes have extensive red rot.

Some volumes have suffered water damage.

Historical Note:

Pickett Coal Company was founded as Pickett & Edwards by Richard Pickett (1780-1864) and Abraham Edwards (1782-1872). The company originally produced sails, simple clothing items, and sold wood and other goods to Beverly and surrounding areas. In addition the sales of goods, Pickett & Edwards operated fishing vessels. The company was located at 15 Water Street and had an office at 164 Cabot Street. In 1844, Edwards sold out of the company and John Pickett (1807-1887) joined his uncle, Richard, and the company was renamed R. & J. Pickett Co.. As the demand for coal grew in the first half of the 19th century, Pickett Coal Company increasingly imported and sold coal. The company never ceased its fishing operations and sales of goods that were imported on the sailing vessels. After Richard Pickett's death in 1864, John maintained the business by himself until his death in 1887. At this time, Horace W. Woodberry and Jesse G. Trask took over and the company was known as the Pickett Coal Company. The company ceased making sails as the demand lessened and steam powered ships became more prevalent. The company was sold to Sprague, Breed, & Brown Company, another coal company, in 1910.

Vessels owned Pickett & Co: Schooner Beverly, 1835; Ship Magnolia; Palladium, 1835; Paragon, 1835; Bark Susan Clark (Named after John Pickett's second wife); Schooner Syren.

Scope and Content Note:

The bulk of the collection is business ledgers for the Pickett Coal Company. The ledgers cover the full history of the business from its founding in 1817 by Richard Pickett and Abraham Edwards to 1910 when the company was sold to Sprague, Breed, and Brown Co. The ledgers document the customers and transactions of the business. In the early years Pickett & Edwards separated their fishing records from their sail and other goods sales records. Later volumes encompass all business transactions.

The volumes are labeled by the name of the business and the years covered in each volume. The volumes are in chronological order. Within a volume transactions are grouped by customer. Customers are not listed alphabetically, each customer whether a person, business or town was given a section of the ledger and all transactions are listed for that customer over the time period allotted for the whole ledger. Most volumes span a number of years.

A log for the Schooner Charles S. Ruben is included in this collection. The Ruben was a fishing vessel operated by Pickett Coal Co.. The ship was owned by John Morgan and the log covers a 10 year period.

Also included in the collection are business records pertaining to the lumber business of George Roundy (1824-1891). Roundy was a prominent businessman in Beverly and originally established himself with his father in shoe manufacturing but later switched to

lumber. After his death his estate was administered by Horace Woodberry who was also charged with maintaining the lumber business. Because of the connection between Roundy and Woodberry, the lumber business records ended up with the records of Pickett Coal Company.
