#### **Abstract:**

This is a collection of papers regarding Beverly's Light Infantry and its service throughout the 19th century. Although papers span the entirety of the century, most pertain to the Civil War, and another large portion comes from the 1810's. The BLI (as they will often be referred in this finding aid) were active during the War of 1812 and the Civil War – where they fought in many battles, perhaps the most famous being the Battle of Cold Harbor in 1864. Being a century-long collection, there are many authors and signers on these documents; however, two authors that appear very frequently are Robert Rantoul (who served with the company in the years after the turn of the century) and J.W. Raymond (who commanded the company throughout the Civil War).

Donor unknown; many original authors – primarily Robert Rantoul and J.W. Raymond.

### **Conservation/Processor's Note:**

Most documents from the Civil War are in good condition, but require careful unfolding; the earliest documents in the collection (those from the first decade of the 19th century especially) are very fragile and require great care. The same is true for many of the small notebooks in the collection – such as the roll books in Series I and the sick books in Series IV.

# Series I: Recruiting, Enlistment, and Roster Papers (1820, 1848, 1861-1865)

**Series Arrangement Note:** The Contents of Series I are presented in a chronological order which also broadly demarcates different subjects. The only pre-civil war documents about rosters are contained in the first two folders. Folders 3, 4, and 5 follow the BLI's enlistment of volunteers through the beginning of the Civil War, and folder 6 does so for officers. Folders 7-10 deal with muster rolls, and 11, 12, and 13 relate to the promotions of officers.
