# Abstract:

These are papers of the Ober family. This collection includes will and estate documents, correspondence, bills, receipts, logs, legal documents, and personal documents from members of the Ober family from the 18<sup>th</sup> and 19<sup>th</sup> centuries accumulated during their daily lives.

The materials were originally in folders and a box and unprocessed. The documents were organized into series based on the family member. The materials are organized by content and chronologically within the series.

# **Biographical/Historical Note**

The Ober family was local to Beverly, Massachusetts in the 18<sup>th</sup> and 19<sup>th</sup> centuries. These papers begin with the Ober brothers John, Benjamin, Samuel and Richard and continue through marriages and subsequent children. The men held positions in the military and as mariners; William Ober was a corporal and advanced to captain in the militia and Josiah was a member of the Lexington Minutemen. The women held gender roles consistent with the times in which they lived; Mary Ober was a school teacher.

Folder 12 is comprised of 89 receipts from Josiah's life and from settling his estate after his death in late 1837.
