# **Beverly Improvement Society Papers** (1888-1991)

#### **Abstract:**

The records of the Beverly Improvement Society. Collection includes secretary records from the founding of the organization until 1991. The records cover society members and leadership as well as projects and initiatives to beautify the parks and homes of Beverly since 1888.

#### **Processors Note:**

This finding aid was based on the collection as stored at the Historical Beverly Archives in 2019. Some secretary, treasurer, and membership notes were stored in binders and notebooks which were kept loose in boxes or as free standing books. Binder materials were rehoused in archive safe plastic binders by a previous archivist.

The majority of the collection was loose documents in file folders. The descriptions and dates of many boxes and files did not accurately reflect the contents. The processor attempted to keep the documents grouped in the way they were filed. It is assumed that the order in which files were grouped in January of 2019 were in some way reflective of their organization by the Improvement Society. Where groups of files seemed miscellaneous, efforts were made to keep the files together to reflect the way the Beverly Improvement Society conducts regular business based on the order of documents and meetings found in Recording Secretary notes and binders.

Meeting minutes, financial records, and administrative documents are organized by date. The rest are organized by topic and by date within those topics where possible. Undated items are filed with the papers they were filed closest to.

There remain some preservation issues, notably several of the binders are full of adhesive and interleaved with newspaper clippings. Administrative Documents files also include some clippings in their original acidic paper that have not been photocopied. These should eventually be photocopied onto acid free paper to better preserve the contents.

#### **Historical Note**

Beverly Improvement Society was established in 1888 to "improve and adorn the town of Beverly and to preserve its natural beauties" according to the original By-Laws. The officers consisted of the first president Mrs. William C Boyden, a vice president, a treasurer, and 2 secretaries including Ms Bessie A. Baker. The executive committee was made up those officers, ten members, and chairmen of sub committees. Later a board of trustees was added. Annual meetings are held every September and executive meetings are held every month. The group was open to be joined by any member of the public for \$1 per year or by planting 1 or more trees in Beverly.

Since its founding, the group has gathered funding and initiatives regarding planting trees, maintaining beaches and parks, advocating for environmental health, and inspiring community involvement in local beautification. The Beverly Improvement Society is the primary caretaker of Lynch Park and received annual funds from the will of David Lynch to maintain and plant the garden. The collection includes records of what plantings were made and how much they cost. The group was also involved in significant building and renovation projects in Lynch park.

Since the beginning of the society, there have been initiatives to encourage local planting especially among children. What started as a children's backyard gardening contest developed into a gardening contest at schools. The collection retains application slips and winner results as well as photographs of some of the backyards and gardens.

The group was also involved in collaborative efforts with other local environmental advocacy and protection groups around issues like Dutch Elm Disease, air and water pollution. In 1961-1963, the Beverly Improvement Society attended and followed legislative initiatives regarding air pollution and smoke ordinance regulation.

Beverly Improvement Society is still active today.

#### **Scope and Content Note**

The collection consists of documents focused on the organization of the Beverly Improvement Society. This includes correspondence, treasurer records, annual reports, meeting minutes, and other financial documentation. There are also newspaper clippings both separate

and interfiled with other administrative documents. Most of the material is dated and organized chronologically where appropriate.

The "Administrative Documents" description is unique to this collection. It reflects the items interfiled together which fall under the kinds of documents included in the Secretary Records: correspondence, meeting minutes, annual reports, newspaper clippings, financial documentation, and occasionally other miscellaneous items. There may be some duplication between the Secretary Records and corresponding Administrative Documents.

Secretary Records and Administrative Documents cover the regular business of the Improvement Society. They note the status of projects, funding, and topics of interest to the group. Annual reports from committees included in these files summarize the work based on the year. Membership can also be determined from these records as well as from the earlier membership books. Receipts might be used to identify local businesses and their locations at the time of the transaction.

The collection also includes a series of collected files that had an unusually large timespan. Some of these include notes for anniversary celebrations. The processor chose to keep these together instead of distributing them into administrative document folders and has labeled them based on the anniversary date that most nearly follows the latest date of the items in the folder. They are filed under Series VIII Miscellaneous, Subseries A: Retrospectives.

Of note: the collection includes photographs taken of backyards and gardens in Beverly in 1895 and 1914 including addresses. These can be found under the Yard Improvement subseries of Series VI: Initiatives and Projects. Photographs of an outdoor society event in 1983 are filed with other Administrative Documents for that year.

Series/Arrangement Note: Administrative Records is the name for the general assortment of files found in folders and secretary notes. These records include correspondence, meeting minutes, committee reports, newspaper clippings, and other notes mixed together. This grouping also matches Recording Secretary's documents and what is presumed to be the order of Improvement Society Meetings. They have been organized into individual file folders based on the Beverly Improved Society financial year as described in the By-Laws, from October 1st to October 1st of consecutive years.

No files were made for the dates 1942-43, 1947-48, 1954-55, 1955-56, 1974-75, 1977-78, 1981-82, 1982-83 because no documents were associated with those dates.
