Records of the First Parish Church in Beverly (1667-2016)

Abstract:

Records of the First Parish Church of Beverly document activities from its establishment in 1667 as a Congregationalist Church though its adoption of Unitarianism in 1830 and its continuation into the 21st century. There are local vital records (i.e., of births, marriages, baptisms, and so forth), financial records, meeting minutes of church committees and societies, Sunday School records, newsletters, and transcriptions of sermons. Photographs and prints, audio-visual materials, and several artifacts supplement the written records.

Provenance:

The records were housed at the church until 2019, when they were transferred to Historic Beverly.

Conservation/Processor's Note:

Bindings of numerous historic volumes suffer from red rot.

A number of 18th- and 19th-century documents reside within the alphabetical subject file, comprising seven record cartons. For the sake of preservation, this file has been split into two parts, with an alphabetical run of historic documents transferred into archival storage, and the larger alphabetical run of modern records stored elsewhere.

Original photographs situated within the subject files have been photocopied, the copies left in place, and the originals transferred to photographic storage (Box 28).

Historical Note

Bass River (the early name of the north side of Salem in the Commonwealth of Massachusetts) did not have its own church in the 1630s and 1640s; inhabitants worshipped at the First Church in Salem. In the 1650 and 1660s Bass River locals employed, successively, Josiah Hobart, Jeremiah Hobart, and finally John Hale as religious teachers. In 1656 they erected a meeting house. The First Parish Church of Bass River was founded was a Congregationalist church in 1667, with Hale as its pastor; in the following year, 1668, Bass River became the town of Beverly. Edwin M. Stone: *History of Beverly, Civil and Ecclesiastical, from its Settlement in 1630 to 1842* (Boston, 1843), 204-255.

In the first decade of the 1800s, a portion of the congregation separated to form the Third Parish Church in Beverly. In 1810, Johanna Prince and Hannah Hill founded the First Parish Church Sunday School. In 1830, with the employment of its seventh minister, Christopher Toppan Thayer, the Congregationalist First Parish Church became a Unitarian church. It continues as a vital local Beverly institution in the 21st century.

Scope and Content Note

Records of the First Parish Church of Beverly span nearly 350 years, from its establishment in 1667 into the 21st-century. Bound volumes hold vital records, documents on meeting house construction and renovation, financial records, records of church committees and societies, and Sunday School records. There are also loose-leaf items, predominantly financial documentation. A substantial alphabetical subject file holds newsletters, sermons, items pertaining to music in the church, and reference materials, while also supplementing many of the aforementioned categories in the bound volumes. In addition to written materials, Records of the First Parish Church in Beverly include photographs and prints, cassettes of recorded sermons, meetings, and services, a few digital audio-visual items, and several artifacts.

Many of the church's documents were originally created within bound volumes that proceed more or less in chronological order. Accordingly, loose-leaf financial documents have been arranged chronologically in binders, to mirror and slot into the relevant handwritten volumes. However, unlike most historical church collections held at other Massachusetts institutions, Records of the First Parish Church in Beverly also include an alphabetical subject file that spans more than two centuries and cuts across the chronological organization. Cross references in the collection inventory highlight links between the subject file and the bound volumes.

In the Content List that follows, many boxes do not have folder numbers. They consist of freestanding items, including bound volumes, scrapbooks, and photo albums. FPC numbers refer to individual items in a comprehensive inventory supplied by the church in an Excel spread sheet entitled <First Parish Archive Finding Aid>. Assigned numbers were duplicated for a few items; some unnumbered items, missing from the inventory, appear here.

Content List

Series I: General Records (1667-1996)

Series/Arrangement Note: Bound volumes collect vital records (marriages, births, deaths, and burials; baptisms, communions, and covenants; dismissals and resignations), financial records, Parish Committee meeting minutes, and records of building and enlargement. The earliest volume begins with Rev. Hale's account of the founding of the church. 1867 and 1882 floor plan of the meeting house are attached within 1830-1872 volume of meeting minutes and treasurer's records. Additional Parish Committee meeting minutes appear in the subject file, Series V.

Portions of the ink on some 17th- and early 18th-century pages in the first volume have now faded to illegibility, but fortunately the entire volume had already been transcribed and published at the beginning of the 20th century, as *Records of the First Church in Beverly, Massachusetts, 1667-1772*, transcribed by William P. Upham (Salem, Mass: Essex Institute, 1905).

Series II: Treasurer's Records (1720-1973)

Series/Arrangement Note: In 1637 the General Court of Massachusetts ruled that the First Parish Church in Newbury, Massachusetts, should be supported by a tax on personal property and real estate. A system of compulsory support of religious worship was fully in place by the time that the First Parish Church at Bass River was founded in 1667 (becoming Beverly in 1668), and this system continued into the 1830s, long after the U.S. constitution separated church and state. Series II consists of bound volumes and loose-leaf items concerning financial matters: warrants, assessments, and other documents relating to tax collection in support of the church; cash books; pew rentals, including deeds and a pew floor plan; pledges and subscriptions; the management of church funds, including Ministerial Fund by-laws and minutes (1830-1942) and Capital Campaign minutes and reports (2006-2007); and documentation of a Christie's auction of church silver (2009-2010).

Because of the normal practice of integrated chronological recordkeeping, extensive portions of the church's financial records are situated within the bound volumes of general records (Series I). Also, substantial additional material resides in the subject file, Series V, under the headings annual meeting reports, financials, ministerial fund, pews, receipts, and tax records.

Conversely, a few documents in the binders of loose-leaf items extend beyond financial considerations. These include an agreement to purchase a bass viol to improve the music at services (undated); committee minutes on parishes and their populations (undated, circa 1800-1810); discussions of the separation into First Parish and Third Parish churches (1802-1803 and undated); a letter demanding that William Lee restrain his wife from disrupting services (1809); and minutes of a committee on the Act Respecting Public Worship and Religious Freedom (1814). Additional documents pertaining to the separation into First and Third parishes reside in the subject file, Series V, under the heading "churches, neighboring: Dane Street."

Series III: Committees and Organizations (1751-2007)

Series/Arrangement Note: Series III holds records of church committees and organizations.

Most of the Parish Committee meeting minutes and financial records are integrated into general records volumes and financial records volumes in series I and II; only a few separate meeting minutes books appear here. Other committees addressed seating at the meeting house, in the 18th century, on buildings and enlargement in the 18th and 19th centuries, and an early 21st-century Capital Campaign. In addition to the scrapbook on buildings and enlargement, an oversize volume collects complete architectural floor plans and elevations for the meeting house as remodeled in 1835, and another oversize volume documents the establishment of the Second Parish House Fund in 1901.

First Parish Church organizations include the Parish Aid Society and its successor, the Parish Aid Alliance, for which there are by-laws, meeting minutes, membership lists, and financial records. The first volume begins with an account of the formation of the Parish Aid Society in 1877 as a women's society for charitable and social purposes. In 1895 it became a "branch alliance," "to bring themselves into harmony with the great body of Unitarian Women" (from the by-laws). Substantial additional documentation of the Parish Aid Alliance resides in the subject file, Series V.

A booklet holds membership lists and by-laws of the Unitarian Total Abstinence Society. There are constitutions/by-laws, meeting minutes, and membership lists for a late 19th- to early 20th-century young person's organization: the Young People's Society, which became the Unity Club (or Unity Guild); and a membership list for the Junior Church in 1944. Meeting minutes and memorabilia preserve activities of a 20th-century social organization, the Old South Club; it is unclear whether it was affiliated with the club of the same name at Boston's famous Old South Church, or whether this is simply a reference to the Old South Chapel within the Beverly church.

Series IV: Sunday School Records (1823-1963)

Series/Arrangement Note: Founding regulations of the First Parish Church Sunday School, with Robert Rantoul as Superintendent, appear within a roll book of attendance, behavior, and recitations from 1823. Numerous volumes hold meeting minutes, registers of teachers and scholars, and attendance records spanning 150 years; the 1860 volume also includes an essay on the founding of the Sunday School. In addition to these functional records, series IV includes a Sunday School library catalog from the mid-1830s, library circulation records, an 1885 edition of the *Sunday School Service Book and Hymnal*, and two scrapbooks of memorabilia, one of which

resides together with, and at the reverse end of, Adelaide A. Lovett's book of exercises for Miss Sanborn's 1910-1911 Physiography class. Substantial additional documentation of the Sunday School resides in the subject file, series V.

Series V: Subject File, Church Publications, Bibles and Hymnals, Secondary Sources, and Memorabilia (circa 1700-2016)

Series/Arrangement Note: This series gathers together a variety of primary and secondary sources. An alphabetical subject file holds information on ministers and other prominent church officials; modern-era annual financial reports; documentation of the formal incorporation of music into church services from 1760 onwards; 20th-century newsletters; transcripts of sermons; and source materials on diverse topics. Some of these folders supplement, or carry forward into

the late 20th century, information found in handwritten volumes; cross-references appear within previous series descriptions. The subject file also contains a small collection of memorabilia.

There are bound volumes of sermons and other writings of First Parish Church ministers. Historical religious tomes include bibles, hymnals, and an 18th-century book of Sacred Harmony. A small reference library complements secondary source materials situated in the subject file.
